
**CITIZEN COMMENTS:**

Administrator Ledford said that she had found a cemetery grant available and discussed the possibility of road crew personnel removing tree limbs at the cemetery.




Trustee Crowley moved to adjourn the meeting at 8:02 pm. Seconded by Trustee Ashbaugh. R/C: All ayes.
