Fire:

Trustee Crowley motioned to reimburse Paige Printz for Paramedic classes in the amount of \$911.42. Seconded by Trustee Brown. R/C: All ayes.

Trustee Crowley motioned to enter into a clinical affiliation agreement between the Bethel Township Fire Department and Clark State Community College. Clinical study provides the capability for learning experienced and recognizes the professional responsibility of teaching students who are interested in assisting the institution. Seconded by Trustee Brown. R/C: All ayes.

Special & Work Sessions:

Trustee Brown moved to set a work / special work session on January 21, 2025 at 6:30pm. Seconded by Trustee Crowley. R/C: All ayes. Discussion will be 2025 Goals.

CITIZEN COMMENTS:

Citizen Don Wallace discussed the difficulty of hiring quality people, as Clark County has one of the lowest employment rates in the state of Ohio. He suggested that 2025 goals discussed in Work session should include competitive pay scales for employees.

Mr. Wallce again suggested an economic impact study.

There was discussion of the Rumpke proposed development. Trustee Ashbaugh stated that everything was completed regarding Rumpke's plans to place a recycling station at the location, and that all that was waiting on was an EPA study, which was not likely to change the plans for development.
