Trustee Crowley motioned to pass a resolution to enter into a contract with the Clark County Sheriff for the 2026 Law Enforcement Agreement with final review. The cost of this contract will include the deputies base pay, sick time payout, comp time payout, projected overtime, extra duty hours, training and retirement funding. Also included are Medicare premiums, worker's compensation, life insurance, dental insurance, health insurance, uniform allowance, and liability insurance. The cost is \$151,552.63 per deputy and \$4,281.84 for Cradle Point Internet access and two Axon cameras for each township cruiser. The total cost of the contract is \$307.387.10. Seconded by Trustee Brown. R/C: All ayes.
