Trustee Brown moves to accept the agenda. Second by Trustee Crowley. R/C: All ayes

Trustee Ashbaugh moves to pay the bills, check numbers 69415 through 69452, and ACH deductions 1722-2025 through 1784-2025 totaling \$95,090.22. Second by Trustee Crowley. R/C: All ayes.

### **NEW BUSINESS:**

#### Administration:

Trustee Ashbaugh makes a motion to accept the contract from United Senior Services. It is the same as last year, except they included the internet in the bill. They agree to pay \$3,480.00 a year for the use of the BTCC for two days a week to hold the USS luncheons. Second by Trustee Crowley. R/C: All ayes (Are we up to date for 2025?)

25-11-24-01 Trustee Brown makes a motion to pass a resolution to accept the Employing Township Attorneys contract with Brosius, Johnson & Griggs, LLC. The new fees are \$235.00 per hour attorney time, \$215.00 per hour senior associate; \$190.00 per hour associate; \$130.00 per hour law clerk, and \$115.00 per hour legal assistant. The board agrees to allocate \$5,000.00 for the year 2026. Second by Trustee Crowley. R/C: All ayes. A TIF committee must be formed

#### Fire:

Trustee Crowley makes a motion to purchase 16 Motorola N70XE Portable Radios from Motorola Solutions with P&R Communications as the vendor for \$101,272.64, with the State Fire Marshals Office providing \$42,500.00 of the total cost and the Fire Department responsible for the remaining \$58,772.64.

Second by Trustee Brown. R/C: All ayes.

Trustee Ashbaugh makes a motion to approve the annual maintenance contract for 2026, quote # QUO4388 with P & R Communications for the 16 APX mobiles and 62 APX portables. The cost is \$8,719.00. Second by Trustee Crowley. R/C: all ayes.

Trustee Brown makes a motion to pass a resolution to accept the Clark County Sheriff's Office Fire Dispatching Contract. The price has remained the same as last year at \$45,470.00. This will be made in two payments due February 1, 2026 & August 1, 2026. Second by Trustee Ashbaugh. R/C: All ayes

#### Road:

A&B Asphalt has sent its final bill to us for the 2025 road contract resurfacing. It is \$18,865.43

Road Supervisor Bryan Stastny stated that he was getting prices on a new blade for the snowplow. He also discussed that we need to advertise for employees for the road department.
