The result of the executive session is as follows: No action will be taken at this time.

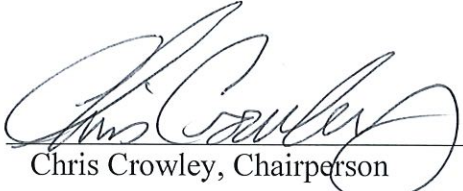

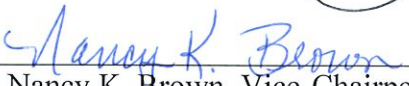

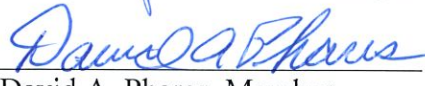
