### **NEW BUSINESS:**

### Administration:

**24-10-22-01** – Trustee Crowley motioned to pass resolution in accordance with Ohio Revised Code Section 5705.34, each taxing authority, by ordinance or resolution, shall authorize the necessary tax levies and certify them to the Clark County Auditor. Seconded by Trustee Ashbaugh. R/C: All ayes.

#### Fire:

Trustee Ashbaugh made motion to hire Raymond Kinard as a FF2 / Paramedic for the Bethel Township Fire Department at a rate of \$22.50 per hour. Seconded by Trustee Crowley. R/C: All ayes.

Ledford also mentioned that she continues to work on medical insurance options for the 2025 calendar year.
