Notes from hearing on June 13, 2023 The property is located at 3117 Lake Rd. Medway, OH. 45341

**Tom Green**: Letter sent 7/12/23 to Ms. McKenzie stating that the property is subject to litigation and the existence of the property is important to the litigation.

*Chief King*: Particularly concerned about access to the building.

**Tom Green**: Asking for time to address this concern, clean up the outside, and retrieve valuable vehicles on the inside of the property. Mr. Bishnow has a prospective buyer. Mr. Green stated that relying on what Mr. Bishnow is saying, the building is a steel & concrete block building that can be salvaged and cleaned up and attractive.

*Trustee Crowley*: Why hasn't anything been done in the ten years we have been trying to get Mr. Bishnow to do something?

**Mr. Green**: Mr. Bishnow has been distracted by other matters. I can't say what has been done in the past but, now he has employed me as his attorney.

**Trustee Phares**: What is your time frame for clean up?

*Mr. Green*: Vehicles will be removed within 30 days. Selling the building requires getting a free title. The court trial date is in August. We are asking for time to clean up the property.

*Mr. Bishnow*: I cannot enter the building to retrieve the vehicles without a court order. Mr. Bishnow claims he has a 10-year plan to get this building done. The building has three (3) Porsches and one (1) Corvette on the inside. He stated he is the caring child for his aging parents in South Carolina. He stated he notified his attorney as soon as he received the letters from Bethel Township.

**Trustees**: We will go into an executive session to discuss all options.
