Two new locks are needed for the interior doors at the Bethel Township Community Center to secure contents for United Senior Services. Trustee Ashbaugh said he may have some that he can donate.

**FIRE:**

The generator at Station 51 has been serviced with oil, oil filter & fuel filter replacement for \$722.00 on 7/19/2024. The generator is performing as it should.

An insurance claim has been started for the back patio cover at Station 51 as significant damage was done by a storm on 7/19/2024.

Trustee Crowley made a motion to hire Emily Way (EMT Basic) to the Bethel Township Fire Department part-time, starting immediately at \$14.50 per hour. Seconded by Trustee Ashbaugh. R/C: All ayes.

Trustee Ashbaugh made a motion to terminate Cody Stanley from the Bethel Township Fire Department due to failure to report to work after being hired last year. Seconded By Trustee Crowley. R/C: All ayes.

#### **ROAD:**

Trustee Ashbaugh made motion to renew the MOU between Bethel Township and the Clark County Commissioners on behalf of the Clark County Buildings & Grounds dept/garage. All prices and services will remain the same. Seconded by Trustee Crowley. R/C: All ayes.

Trustee Ashbaugh made a motion to approve the quote from J&B Transmissions for the 2006 Ford F450 Super Duty truck. They will replace the transmission for \$7,091.61 which includes a 3-year warranty. Seconded by Trustee Crowley. R/C: All ayes.

The Bobcat ZT6000-W/FX801 KAW 61SD mower was purchased and delivered on 7/18/2024. The cost was \$10,800.00 from RC Enterprises. This purchase was paid for from the 2231 Permissive Motor Vehicle Tax Fund.

Discussion regarding hiring a full-time road replacement for Dan Keeton. Trustee Crowley says to move forward with a full-time replacement.



#### **Special & Work Sessions:**


