Special Session

Trustee Nancy Brown makes a motion to leave the regular session and enter the executive session @ 4:57 pm. Second by Trustee Dave Phares. R/C: All ayes.

Trustee Dave Phares makes a motion to leave the executive session and re-enter the regular session @ 5:39 pm. Second by Trustee Nancy Brown. R/C: All ayes.

As a result of the executive session:

Trustee Nancy Brown makes a motion to require all employees of Bethel Township to watch The Ohio Ethics Law 2023 video and pass the quiz within 30 days of the notice and provide the township with a completion certificate. Second by Trustee Chris Crowley. R/C: All ayes.

23-01-17-01 Trustee Nancy Brown makes a motion to pass a resolution to approve Jacob King and Keith Hawkins to perform duties with Clark County Sheriff's Office Special Operations Team, this includes training, Team call outs, Drone call outs and any other special requests primarily in Clark County but any location the Team is requested to respond. This resolution also provides these duties are in the performance of work for Bethel Township and authorizes Jacob King and Keith Hawkins to carry their personally owned firearms in the performance of duties and as approved by Clark County Sheriff in accordance with Ohio Revised Code 109.771-109.78. 23-01-17-02 Trustee Nancy Brown makes a motion to pass a resolution to allow Chief Jacob King to purchase from Bethel Township the 19G5 MOS Glock with sights for \$720.00 that was purchased under the resolution 22-03-22-03. This gun shall now be the personal property of Chief King. The other items bought under the same resolution which are one (1) Safariland 6360RDS holster @ 169.95, one (1) drop leg holster adapter @ 89.95, one (1) TLR-1-HL firearm light @ 154.95, one (1) Trijicon RMR 2 3.25 MOA @ \$494.95, One (1) RMR Mounty kit @ \$32.95 and one (1) QLS kit @ \$34.00 will be put into Bethel Townships inventory on UAN and continued to be owned by Bethel Township.
